Introduction

This report is a summary of the services provided by Planning & Development District III during the past twelve months. The document contains general organization information, regional service highlights, and specific county work activities.

Background

District III is a voluntary association of county, municipal, and Tribal governments that was established in May 1973. Its membership also includes area organizations and development interests. The 15county region is a U.S. Economic Development Administration designated "Economic Development District". District III is considered to be a "guasi-governmental" organization.

Funding

District III is financed through membership dues, administrative charges, state and federal agency service contracts, special purpose grants, and technical assistance fees. The 2009 expense budget was \$907,066. Approximately 28% of District III funding comes from local government dues.

Twelve Month Highlights

The following programs, services, and assistance activities were provided throughout the region.

- A total of 125 applications were prepared.
- Successful proposals resulted in \$21,524,851 of outside funding.
- 14 cities and counties were assisted with land use planning or zoning issues.
- 13 businesses received Areawide Business Council (ABC) loans totaling more than \$820,000.
- ABC assistance leveraged nearly \$2.2 million in private investment. There were 62 jobs retained.
- In 2009, the Small Business Development Center (SBDC) assisted 158 business clients, which resulted in 137 new jobs and \$14,820,529 private investment.
- Geographic Information System (GIS) services were used by 20 entities.
- 13 Governor's House units were sold in the region, bringing the overall total to 324.
- Ongoing technical assistance was provided to the Missouri Sedimentation Action Coalition and MRC Regional Rail Authority.
- District staff attended a total of 385 separate, out-of-office meetings throughout the region. District III staff used internet based "GoTo Meetings" on 307 occasions during 2009 which is a significant increase from the 128 occasions in 2008. This technology was used primarily in GIS consultations
- Procurement Technical Assistance Center (PTAC) services were provided to 25 companies. PTAC assists companies with government contracting.
- District III continued to assist the South Dakota Department of Transportation with a road inventory project.
- Progress was made on Pre-Disaster Mitigation Plans for 12 counties.
- Initial work was completed on 67 Energy Efficiency and Conservation Block Grant (EECBG) applications.
- A total of 54 local governments were assisted with Central Contractor Registration (CCR) activities. CCR is becoming a federal program eligibility criterion.

Overall Funding Total

Since 1973, District III has assisted its membership in obtaining \$237,545,192 in outside funding assistance. This figure represents \$2,324 for every person in the region (based on 2000 Census).
