Regional Main Street Program to Benefit Downtowns

Planning and Development District III, through a grant from USDA Rural Development, will improve the economic development opportunities in its region by offering intensive technical assistance, utilizing the National Trust's "Main Street Program." A total of four communities will be trained in implementing Main Street's Four Point Approach — a proven solution for downtown revitalization.



The Main Street program is designed to improve all aspects of the downtown or central business district, benefits. Improving producing real management, strengthening public participation, and making downtown a fun place to visit are as critical to Main Street's future as recruiting new businesses and rehabilitating buildings. Building on downtown's assets -- rich architecture, personal service, traditional values, and most of all, a sense of place -- the Main Street approach has renewed private enterprise, downtown cooperation, and community pride. It has earned national recognition as a practical strategy appropriately scaled to a community's local resources and conditions. And because it is a locally driven program, all initiative stems from local issues and concerns.

The Main Street Program is centered on a Four Point Approach to downtown revitalization. The Four Points are:

- Design Enhancing the physical appearance of the commercial district by rehabilitating historic buildings, encouraging supportive new construction, developing sensitive design management systems, and long-term planning.
- Organization Building consensus and cooperation among the many groups and individuals who have a role in the revitalization process.
- Promotion Marketing the traditional commercial district's assets to customers, potential investors, new businesses, local citizens, and visitors.
- **Economic Restructuring** Strengthening the district's existing economic base while finding ways to expand it to meet new opportunities and challenges from outlying development.

Participants in the Main Street Program will represent many facets of the community. They include merchants, property owners, chambers of commerce, financial institutions, civic clubs, historic societies, consumers, elected officials, schools, and the media. District III staff will provide technical assistance in an intensive three or four month period, focusing on all four points of the Main Street Program. The staff will be responsible for helping to organize a local team of participants (one of the Four Points) and create several committees. Each committee will focus on a different aspect of the Main Street Approach. Training material and demonstrations will be presented in ways that help recipients appreciate and understand the information. District III will supply each committee member with their own packet of information pertaining to the particular committee on which they serve.

District III is already working with representatives in Scotland and Plankinton on their Main Street program. Two more communities, which have yet to be chosen, will receive assistance in 2006.

DIRECTOR'S CORNER

Housing as Development

Prairieland Housing Development (PHD) is "turning dirt" in four communities. When the construction is finished in August, eight Governor's House units will be ready for sale to eligible buyers. Hopefully, some of the new owners will be families with children to add to local school enrollments.

PHD was formed to help create housing opportunities in smaller communities. It represents a calculated risk, based in part upon the expectation that, if we build it, they will come. The homes will include a full basement and double garage. The asking price should be very competitive.

The success of PHD depends upon the cooperation of local development groups and funding from the South Dakota Housing Development Authority (SDHDA). PHD has benefited from free or low cost lots and infrastructure assistance. The Housing Authority has supported PHD with very low interest financing. The only "red flag" we encountered was an excessively competitive attitude from individuals in one community. Community competition is not only healthy, but essential in motivating change — but a strong negative attitude about neighboring towns is a condition that discourages lasting progress.

The District III Committee is all about regional cooperation and mutual development opportunities. PHD will benefit the communities where the units are built, as well as neighboring areas. A guiding principle for the program is that we will only offer housing where it is both wanted and supported. Our initial experience has reinforced that policy. If your community wants PHD to be part of its development future, its leadership must put aside petty rivalries associated with the past. We will be looking for another four towns to participate in PHD during Local attitudes will be part of the 2006. screening process.

District III Leadership Changes

District III has always benefited from two opposing forces – continuity and change. Two long tenured Executive Board members recently left their leadership posts.

Art Hertz had served as the District III Chairman and representative from Gregory County. Art will remain on the Committee as the representative from the Great Lakes of South Dakota Association. Anyone who has met Art knows he has a gift for making his points with humor and an endless supply of stories.

Milford Markus represented Brule County for many years. His terms on the Executive Board were marked by loyalty and a wealth of common sense. Milford was a former highway patrolman and he knows this region inside and out.



Recreation Resources

Periodically throughout the year, District III receives information regarding funding for specific recreation programs. Recently we received information from the United States Soccer Foundation and the United States Golf Association (USGA) regarding financing options for developing soccer and golf programs for youth.

The U.S. Soccer Foundation began awarding grants in 1995, and has provided almost \$17 million dollars in cash and equipment to more than 300 grantees. The Foundation has given grant money to organizations ranging from small rural clubs to large urban areas. The goal of the program for FY2005 is to focus on funding programs or projects that develop players, referees, and coaches, with special emphasis on the economically disadvantaged in urban areas. Grants are open to anyone with a soccer specific project that will benefit a not-for-profit purpose and meet the established goals previously mentioned. Generally, application requests are not funded at 100%.



The Foundation also supports construction of fields by sponsoring the All Conditions Fields (ACF) Program. In 2003, the Foundation partnered with Nike and four Resource Center Partners to package a regulation size, synthetic surface pitch (FieldTurf), a set of field lights (Musco), field equipment (Kwik Goal), and signage (TGI Systems), at a significantly reduced price from retail cost. Grants up to \$100,000 per award are available to purchase the package and qualifying organizations are eligible to apply to GE Capital to develop a financing package for the remaining funding. A letter of intent must be sent to the Foundation by August 1, 2005, after which the committee will contact the applicant to request a full application if approved.

The United States Golf Association provides grant funding through its "For The Good Of The Game" grant program. The primary focus of the program is for organizations that introduce golf to people who would not otherwise have the opportunity, specifically kids from economically disadvantaged backgrounds and individuals disabilities. Grant awards can be utilized for instructional programs, caddie or other work-based curriculums, and the construction of facilities that make the game both more affordable and accessible. The USGA will also consider funding requests for items such as golf course/practice range access, golf instruction, equipment,

costs for alternative, beginner friendly golf courses and facilities in areas where there are obstacles to affordable access to the game. Applications are due in January and July for funding decisions in May and November.



Governor's House Program

The following guidelines are effective <u>as of October 18,</u> 2004:

- The price of the home is \$30,800
- Households of <u>2 OR LESS</u> must have an income less than \$33,500.
- Households of <u>3 OR MORE</u> must have an income less than **\$36,750**.
- Households <u>UNDER 62 YEARS OF AGE</u> must have a net worth less than \$100,000, of which no more than \$70,000 may be in liquid assets.
- Households <u>OVER 62 YEARS OF AGE</u> must have a net worth less than \$175,000, of which no more than \$100,000 may be in liquid assets.

Regional Map Server Update

District III has been talking with county governments in our service area to find out if they are interested in participating in the development of a Regional Map Server.

A regional map server is a web-based program that will provide internet access to GIS data. This map server would allow county and city government personnel, as well as local citizens, to access various types of GIS data 24 hours a day, seven days a week. Using a web browser, individuals will be able to perform many different tasks, such as customizing maps, querying various databases, creating buffer areas around a specific location, and extracting general information. This service would be a tremendous resource in helping county and city governments operate more efficiently.

As of June 2005, five counties have indicated strong interest in the project. Those counties are Lyman, Brule, Hanson, Sanborn, and Yankton. District III has recently purchased the internet mapping program and it will be ready for demonstration soon.

The Board of Directors of the Areawide Business Council met in Mitchell on Friday, June 10, 2005 for its annual planning session. Greg Henderson facilitated the meeting with assistance from Pat Hansen. Sue Stoll, Regional Director of the Small Business Development Center, also attended the session to share her perspective on marketing the ABC program and its comparison to other sources of financing.

The Board covered many topics throughout the day and ultimately reaffirmed its mission to continue "providing low interest financing for new and expanding businesses". This assistance is intended to promote the development of business concerns, create jobs, leverage other public and private funds, and diversify the area's economy.

ABC is in the fortunate position to have over \$1.5 million available to lend for projects in the District III service area. A portion of this funding is from the State of South Dakota Rural Economic Development Initiative (REDI) Fund. As part of the 2010 Initiative, Governor Rounds approved lending \$3 million to the six regional revolving loan funds in the state. ABC has therefore been charged with the task of identifying qualified borrowers in our region who will benefit from an injection of low interest funding as they start or expand their business. Unique Opportunity for Emergency Service Organizations

District III staff recently came across information about a donation program from the U.S. Smokeless Tobacco Company (UST). Eligible organizations can apply for donation of a Polaris Ranger 6x6 utility vehicle (pictured here).



More than 1,300 applications were submitted for the 2005 program, a 30% increase over 2004. UST expects to award approximately 70 utility vehicles in three rounds of awards throughout this year.

- EMS/Ambulance
- Search & Rescue
- Park/Forest Ranger

In 2004, fire departments in Aberdeen and Hayward, South Dakota received Trail Gator vehicles from UST.

The deadline for 2005 has passed, but applications for 2006 will be accepted beginning in the fall.

The Importance of a Business Plan

It forces people to "get organized" and "get serious" about their business idea.

If funding a project is not an issue, the need for planning cannot be minimized. SBDC consultants also see clients who are <u>not</u> seeking financing, but want to make sure they have a good plan. We are glad to assist in whatever role is best for the client.

Funding Opportunities in South Dakota for Brownfield Projects

The term "Brownfields" is defined as abandoned properties that are difficult to redevelop because of the presence, or potential presence, of a hazardous substance, pollutant, or contaminant. Cleaning up and reinvesting in these properties takes development pressures off of undeveloped land, and improves and protects the environment. Although South Dakota has fewer Brownfields than larger urban states, we do have our share. Common types of Brownfields in this state include abandoned gas stations, junkyards, old rail yards, and grain elevators. Any site where contaminants, pollutants, or hazardous materials once were handled or stored is potentially a Brownfield.

Both the U.S. Environmental Protection Agency (EPA) and the South Dakota Department of Environment and Natural Resources (DENR) provide funding to assess the degree of contamination of Brownfields, and to clean them up. DENR works with municipalities to identify potentially eligible Brownfields sites. Once identified, DENR can hire an environmental contractor to perform on-site testing and, if necessary, develop cleanup plans and cost estimates. This work is performed at no expense to the municipality. If extensive pollution or contamination is found, DENR will encourage the municipality to apply directly to EPA and compete on a national basis for an individual Brownfields cleanup grant. If successful, the community must provide a 20% match to the federal funds.

The following conditions generally apply whether federal or state funds are being applied for:

- There is a strong local commitment to cleaning up the property.
- There is a clear community vision and support for property revitalization.
- There are adequate leveraged funds available for cleanup and redevelopment, and/or the site has strong development potential.

Regarding eligible entities, DENR will consider looking at a privately-owned site if there is a clear means of paying for cleanup, should site conditions warrant such action. Under EPA's Brownfield program, privately-owned sites are not eligible for assessment or cleanup funding.

The central theme behind the Brownfield movement is that environmental protection and economic development can be mutually supportive. The ultimate goal is to return environmentally-impaired property to productive use. **If you have questions about a potential Brownfield in your community, please contact John at the District III office.**
